STATEMENT OF CLAIM

On December 28, 2001 at 6:17 PM, an autodialed, prerecorded voice telemarketing phone call was sent from Defendant's phone number to Plaintiff's home telephone number in violation of the Telephone Consumer Protection Act of 1991 ("TCPA") (47 U.S.C. § 227 (b)(1)(B)). The message was a telemarketing pitch for prepaid legal services. Plaintiff has no prior business relationship with defendant, and has not consented to receiving such calls. The TCPA affords Plaintiff a private right of action in State court pursuant to 47 U.S.C. § 227 (b)(3). The Superior Court of the District of Columbia (Civil Division-Small Claims and Conciliation Branch) has jurisdiction over this matter pursuant to D.C. 11-921 and D.C. 11-1321. Defendant is engaged in willing and knowing violations of the TCPA, and Plaintiff requests minimum liquidated damages of \$500 and treble damages pursuant to 47 U.S.C. § 227 (b)(3)(C).
